Operation and Maintenance

On-going Maintenance

Fence replacement at Site 11 completed last week and request submitted to TSSWCB for reimbursement of under the O&M grant program.

Fence replacement is underway at Site 19 and contractor has indicated they will wrap up work by the end of next week. Contractor has requested consideration that payment be approved upon completion and not required to wait until next ECWA board meeting. This work is also funded by the TSSWCB O&M grant program.

Recent storm/rainfall event

Sites performing as designed over the past month. Visited 15 sites after particularly heavy rainfall around Memorial Day. Detention of floodwater varied across the watershed, with some over the inlet structures with full pipe flow, while others flowing much less. All had a good bit of storage capacity remaining with none nearing auxiliary spillway flow.

TSSWCB Repair Program

Plunge Basin Repairs Sites 37, 38, 43

Start of repairs delayed due to wet conditions. Original notice to proceed date of May 20 was revised to June 1. Contractor began mobilization this week at Site 37. This contract is \$317,690, with 95% cost-share from the TSSWCB dam repair program. Contract performance time is 132 days from the notice to proceed.

Dam Upgrades Site 23 and 39

Site 23 Land Rights

Waiting on completion of corn harvest when Hughes Surveying will conduct metes and bounds survey on the four properties at Site 23 where additional easement is needed for the dam upgrade project.

Site 39 Land Rights

AECOM, the engineering firm working on the upgrade design, provided CAD files for use by Hughes Surveying to conduct metes and bounds survey to identify and mark additional easement areas needed on the Benolken property. Mr. Benolken would like the metes and bounds survey to be completed before they enter into any agreement for compensation in exchange for granting the additional easement. Coordinating with Hughes to initiate the survey.

Site 23-The survey is delayed till corn is harvested.

Site 39-CAD files have been received and sent to surveyor. Landowner has asked for the easements to be identified on the ground. Mr. Sanders is working with all parties to accommodate.
